Universal and correct wearing of masks	Y	Currently the SDA face mask policy does not require students or staff employees to wear face masks. Masks are strongly encouraged for all students and staff members. All visitors to the school are required to wear face masks.
Modifying facilities to allow for physical distancing (e.g., use of cohorts/podding)	Y	SDA will post signs in highly visible locations that promote everyday protective measures including hand hygiene, respiratory etiquette, encouraging face coverings, physical distancing, and describe how to stop the spread of germs. SDA will encourage social distancing when feasible. Desks in all classrooms will face the same way, be spaced, and desk dividers will be utilized for all students in all classrooms. Student seating will be spaced in the lunchroom to enable social distancing. Students will be grouped in cohorts as possible.
Handwashing and respiratory etiquette	Y	SDA will encourage and reinforce handwashing with soap and water for at least 20 seconds after bathroom use, before and after recess, and at other appropriate times during the day. Hand sanitizer will be provided when necessary.
Cleaning and maintaining healthy facilities, including improving ventilation	Y	SDA classrooms will be cleaned routinely throughout the day, anytime there are transitions of student. Desk dividers are to be cleaned daily. All cleaning will be documented on the Classroom Cleaning List. Front office staff will clean all high touch areas throughout the campus including door handles as scheduled throughout the day. The cleanings will be documented. All classrooms and common areas will be cleaned and disinfected every evening using the services of a professional cleaning company.
Contact tracing in combination with isolation and quarantine, in collaboration with the State, local, territorial, or Tribal health departments	Y	SDA contacts the local county health department for guidance in the case of a known staff member or student testing positive for COVID-19 and follows guidance provided by the department. The guidance includes quarantining as appropriate. The local county health department guidelines will also be followed in

		cases where students and/or staff members exhibit COVID-19 symptoms. Students and/or staff members will be required to quarantine and/or provide a negative COVID-19 test result to return to school as recommended by the local county health department.
Diagnostic and screening testing	Y	SDA will participate in diagnostic and screening testing in accordance with state guidelines.
Efforts to provide vaccinations to school communities	Y	SDA has and will continue to share information with school staff and the community about available vaccination locations and information.
Appropriate accommodations for children with disabilities with respect to health and safety policies	Y	SDA makes accommodations for children with disabilities with respect to health and safety policies as needed.
Coordination with State and local health officials	Y	SDA contacts the local county health department for guidance in the case of a known staff member or student testing positive for COVID-19 and follows guidance provided by the department. SDA administration contacts the local county health department as needed for guidance and monitors and follows all updated guidance as it is made available.

### How the LEA will Ensure Continuity of Services?

**SDA is currently offering in-person instruction to all students for SY21-22. Teachers are required to maintain an updated Google Classroom for students to access curriculum if they are required to quarantine. This ensures a continuity of services.**

### Students' Needs:

Academic Needs	SDA has continued to provide rigorous, data-driven instruction aligned to the Arizona State Standards throughout the COVID-19 pandemic. Special education services and other additional services have continued to be provided. Assessments have continued and the teachers and the administration continue to analyze the data compiled from the assessments to ensure all instructional supports needed are provided as needed.
Social, Emotional and Mental Health Needs	SDA has continued to offer Mindfulness strategies and activities in the classrooms to support social, emotional and mental health needs. Teachers are also trained in the importance of creating relationships with their students to support their SEL needs.
Other Needs (which may include student health and food services)	SDA has continued to make breakfast and lunch available to all students through the NSLP/SFSP program.

### Staff Needs:

Social, Emotional and Mental Health Needs	SDA has held professional development sessions related to the wellbeing of staff including their social, emotional, and mental health needs. Administration meets regularly with all staff members to ensure that their needs are being met.
Other Needs	SDA administration meets regularly with staff members and other needs have been addressed with staff on an as-needed basis.
